

Regulations for the 4th ASPAS International Astrology Conference:

General Provisions:

1.1. These regulations pertain to the "Astrology" space, taking place on May 9, 10, 11, and 12, 2025, as part of the 4th ASPAS International Astrology Conference in Vila Nova de Gaia- Portugal.

1.2. The promotional periods in the astrology space will be divided into several sessions, according to the following schedule:

May 9, 2025 | Friday | from 6:00 PM to 8:00 PM – guests and organizers – Rebelo Boat – Douro River presentation and credential delivery;

May 10, 2025 | Saturday | from 10:00 AM to 1:00 PM and from 3:00 PM to 7:00 PM;

May 11, 2025 | Sunday | from 10:00 AM to 1:00 PM and from 3:00 PM to 7:00 PM;

May 12, 2025, | Monday - special post-conference | from 10:00 AM to 1:00 PM;

1.3. The schedule may be subject to changes according to the program.

1.4. Each session, per author, will last fifty minutes regardless of the number of works presented.

1.5. Each mini course, per author, will last three hours regardless of the number of works presented.

2.0- Speaker Participation:

2.1. Astrologers residing in Portugal and abroad may participate in this space.

2.2. participate, interested individuals must send their availability address: То to our email inscricao@associacaoportuguesadeastrologia.com or geral@associacaoportuguesadeastrologia.com by June 30, 2024. They must submit two topics for the lecture and two topics for the mini courses to be presented, for the committee to choose one topic, along with their biography.

2.3. If speakers wish to present their books for sale, they must submit them by December 31, 2024.

2.4. The promotion mentioned in point 2.3 is the sole responsibility of the author.

2.5. The organization promotes the "astrology" space through the association's website, the Portuguese Astrology Association's social media, and the program on-site.

2.6. Authorization for presence will be sent by email by July 31, 2025, safeguarding the capacity of the space, by the direction of the association, which is also the committee for this event.

2.6.1. The committee reserves the right to decline any request for participation, citing space capacity, without providing any further justification.

3.0- Exchanges and Refunds – 4th ASPAS International Astrology Conference

3.3. If you wish to make an exchange, written authorization via email or registered letter to the headquarters of ASPAS – Associação Portuguesa de Astrologia is required, including purchase identification and the details of the person to whom the exchange is transferred, including their tax identification number and respective ID, C.C., B.I., or Passport.

3.4. In case of a refund, bank, Paypal or Mbway feeswill be charged 20 days after the purchase. After thisperiod, ASPAS – Associação Portuguesa de

Astrologia reserves the right not to issue a refund but to accept an exchange for another participant within the indicated timeframe. For a refund, a signature on the credit note of the issued receipt is mandatory.

3.5. Once the conditions for Exchanges and Refunds are met, refunds are processed within a maximum period of 10 days, upon receipt of the respective bank NIB.

4.0- Final Provisions:

4.1. All expenses not considered in these Regulations as the responsibility of the organization, are the responsibility of the authors.

4.2. All information and/or documents provided by the authors must be clear, correct, precise, and truthful.

4.3. Any doubts, disagreements, or situations not covered by these regulations will be reviewed and judged solely and exclusively by the organization, and their decisions are final and binding.

4.4. Participants hereby authorize, regardless of any other form of formalization and/or signature, the free dissemination of their data through any communication channels, such as newspapers, magazines, television, internet, and others, for two years from the date of the official announcement of their presence at the congress.

4.5. The authorizations described in the previous point do not imply any obligation of disclosure or payment of any amount by the organization, except in situations where workshops will be held, and where percentages will be agreed upon.

4.6. The organization is not responsible for irregularities in the presentation of these editions due to internet access problems, hacker intervention, viruses, maintenance, power outages, software or hardware failures, as well as fortuitous events or force majeure, and no compensation is due from the organization.

4.7. The possible commercialization of the works by the authors during the conference is entirely their responsibility, as is the presentation of the works and the respective percentages and values assigned.
